Amendment #75, Bennet #2: An amendment to authorize discretionary action against a foreign country engaging in unreasonable acts, policies, or practices relating to the environment – agreed to by voice vote.

Final Passage of An Original bill to reauthorize trade facilitation and trade enforcement functions and activities, and for other purposes – agreed to by voice vote.
