**US Tariffs on Certain Cutting Tools  
S. 3151, S.3152, and S3135**

Thank you for giving Woodcraft Supply, LLC (Woodcraft) the opportunity to be aware of and provide feedback for the three bills (S.3135, S.3151, and S.3152) that are currently pending in Congress that would temporarily suspend the US tariff on US imports of certain router bit sets, drill bit sets and drill/driver bit sets.

Woodcraft would support these bills under the following conditions:

1. If the bill(s) were written to include the additional quantities of:
  - 6-piece, 10-piece, 12-piece, and 20-piece router bit sets.
  - 4-piece, 5-piece, and 7-piece drill/driver bit sets
  - 7-piece, 16-piece, and 24-piece Forstner bit sets.

OR

2. If the specific quantities of router bit sets, drill bit sets and drill/driver bit sets were omitted altogether to provide a level playing field for all companies in the US who currently supply these products.

If neither of these conditions are met, Woodcraft does NOT support these bills as written due to the fact that there are only one or two companies in the US who currently purchase/sell router bit sets, drill bit sets and drill/driver bit sets in the quantities detailed in the proposed bills, and passage of these proposed bills would give those companies an unfair 5% advantage in the cost of those products.

Dear Mr. Chairman:

I am writing on behalf of Central Purchasing, LLC. in support of the following legislation:

**S.2972** to suspend temporarily the duty on certain 16-inch variable speed scroll saw machines

**S.2976** to suspend temporarily the duty on 6-inch bench grinders for grinding, polishing or otherwise finishing metal or cement, valued under \$3,025 each

**S.2977** to suspend temporarily the duty on 8-inch bench grinders for grinding, polishing or otherwise finishing metal or cement, valued under \$3,025 each

**S.3135** to suspend temporarily the duty on 40-piece carbide router bit set for woodworking

**S.3151** to suspend temporarily the duty on 120-piece, 90-piece, and 60-piece drill bit sets for woodworking

**S.3152** to suspend temporarily the duty on 120-piece drill and driver bit sets for woodworking

Central Purchasing, LLC., established in 1968, imports from worldwide and does not manufacture any of the above mentioned items in the United States. Furthermore, in our experience and to our knowledge most of the major American branded products in these categories are produced outside of the United States.
