1	OPENING STATEMENT OF HON. MAX BAUCUS, A U.S. SENATOR FROM
2	MONTANA, CHAIRMAN, COMMITTEE ON FINANCE
3	
4	The Chairman. The committee will come to order.
5	Today the committee has before it S.J. Res. 17, a
6	joint resolution renewing import restrictions in the
7	Burmese Freedom and Democracy Act, and the nominations of
8	Miriam Sapiro, to be Deputy U.S. Trade Representative;
9	Dan Tangherlini, to be Assistant Secretary of Treasury
10	for Management and Chief Financial Officer at Treasury;
11	Carmen Nazario, to be Assistant Secretary for Family
12	Support at HHS; William Wilkins, to be Chief Counsel for
13	the IRS and an Assistant General Counsel for Treasury;
14	Kim Wallace, to be Deputy Under Secretary for Legislative
15	Affairs at Treasury; George Madison to be General Counsel
16	at Treasury; and Rosa Rios to be U.S. Treasurer.
17	The committee will first consider S.J. Res. 17, a
18	resolution to renew the existing import ban on products
19	from Burma.
20	Aung San Suu Kyi, the Nobel Peace Prize winner and
21	democracy leader from Burma said: "The struggle for
22	democracy and human rights in Burma is a struggle for
23	life and dignity. It is a struggle that encompasses our
24	political, social and economic aspirations."
25	By approving S.J. 17, we can stand with the people

of Burma in their struggle to secure their basic human 2. rights. 3 Sadly, the Burmese government remains determined to make this struggle a long and painful one. It continues 4 5 to suppress political opponents, conscript children into the military, abuse the rights of workers, and allow 6 7 trafficking of people, particularly women and children, 8 with impunity. 9 Unilateral trade sanctions are often not an 10 effective tool to achieve our foreign policy goals. in the case of Burma, several of our trading partners, 11 12 including the European Union, Canada, and Australia, have 13 joined us in imposing trade and investment sanctions. 14 While the Burmese regime has maintained its grip on power, these sanctions have had a meaningful effect on 15 16 the Burmese leadership. I, therefore, urge my colleagues 17 to support this resolution. 18 We also came together today to approve seven pending nominations. The President asked these nominees to lead 19 20 our country through unprecedented challenges. 21 they must provide legal and policy quidance that will address economic uncertainty, both home and abroad. 22 23 Each of these nominees has demonstrated dedication, 24 creativity, and ingenuity in their previous positions.

They will be called upon to use all of these attributes

1	in their new positions. They must help restore America's
2	economic strength as we adapt to new and uncharted
3	territories. The President is confident that each of
4	them is up to the task. And so, let us proceed. I am
5	confident as well.
6	Let us come together to complete these two critical
7	tasks. Let us reauthorize and renew our sanctions on
8	Burma so that the Burmese people will know that we stand
9	with them in their struggle. And let us approve these
10	nominations, so our country can have the leadership
11	necessary to ensure a better tomorrow.
12	I now recognize Senator Grassley for any opening
13	remarks that he may wish to make.

1	OPENING STATEMENT OF HON. CHUCK GRASSLEY, A U.S. SENATOR
2	FROM IOWA
3	
4	Senator Grassley. Thank you, Senator Baucus. Mr.
5	Chairman, I appreciate the opportunity to work on this
6	issue, as we have several times, that you and I have
7	worked together in this committee.
8	The record of Burma on human rights is extremely
9	poor. There is a pattern of government policies
10	suppressing liberties. The abuses have been very
11	extensive, and the trend, sadly, continues to be worse.
12	There are reportedly 2,100 political prisoners that
13	are behind bars, as well. The leader of the opposition
14	has spent 13 out of the past 20 years under house arrest
15	In December 2006, the United Nations General
16	Assembly adopted a resolution expressing its grave
17	concerns over these human rights violations by Burma.
18	Burma poses serious risks to peace and security in
19	the region. This is not the time to reward the bad
20	actions and actors of the illegitimate Burmese
21	government.
22	We should send a very strong signal to the
23	government, particularly because it is military, but
24	otherwise as well, that their ongoing behavior is
25	unacceptable. So, I urge my colleagues to vote in favor

of continuing the trade sanctions against Burma for 2. another year. During this meeting, the committee will also 3 consider favorably reporting the nominations of seven individuals to the full Senate for consideration. 5 Ι intend to support all seven. 6 7 However, my support for the final confirmation of 8 Mr. Madison, nominated to be General Counsel of the 9 Treasury Department, will ultimately rest on his continued responsiveness, and responsiveness of the 10 Department, to my questions. 11 12 I take my oversight responsibilities very seriously, 13 and right now, I am very concerned that this Special 14 Inspector General for the Troubled Asset Relief Program 15 is not getting the cooperation Congress entitled him to 16 from the Treasury Department, and that his 17 recommendations are not being seriously considered. 18 Just two days ago, as an example, Mr. Barofsky testified before the House Committee on Oversight and 19 Government Reform: "Although Treasury has taken some 20 21 steps towards improving transparency in the TARP program, it has repeatedly failed to adopt recommendations that 22 23 the Special Inspector General for TARP believes are 2.4 essential for providing basic transparency and fulfill 25 Treasury's stated commitment to implement TARP 'with the

highest degree of accountability and transparency 1 2. possible." 3 This is not acceptable and I intend to keep pursuing this issue, along with questions regarding \$2.4 million in bonuses to AIG executives that are still at issue in 5 6 the Department, and any bonus payments that may be paid 7 out in the future. 8 Additionally, I want to note that Carmen Nazario, 9 the President's nominee for Assistant Secretary of Children and Families, Department of HHS, is on the 10 agenda today. 11 12 I will support Ms. Nazario's nomination moving 13 forward. I do have an outstanding issue regarding the 14 release of key data of the State's TANF participation 15 rates that need to be resolved. This issue will need to 16 be resolved prior to confirmation by the full Senate. 17 I am not picking on the Treasury Department or HHS 18 specifically here, but all government agencies, and 19 especially agencies that have Presidential nominees that 20 come through this committee need to know that I have 21 always placed great importance on congressional oversight, and that is going to continue. 22 23 And I might say in regard to that, I have always had 24 the support of the Chairman of the committee, as well,

and I hope I have previously supported him in that

1	effort.
2	The Chairman. I might say, Senator, we have always
3	supported each other, very strongly. In this case, you
4	continue to have my support.
5	Senator Grassley. Thank you.
6	The Chairman. All right.
7	We will now recognize other Senators who wish to
8	make any statements with respect to the Burmese
9	resolution, or the nominees for that matter. I am sorry.

OPENING STATEMENT OF HON. MIKE ENZI, A U.S. SENATOR FROM 1 2. WYOMING 3 Senator Enzi. Mr. Chairman, on the Burmese issue, 5 I sympathize with the intent of the resolution, but I have always opposed it on the basis that it is unilateral 6 7 and not multi-lateral. And when the United States takes 8 an effort and has no one else join them, it virtually has 9 no effect. I quess it makes us feel good when we pass 10 those, but as a result I have always opposed the Burmese issue and will continue to do that. So, if we have voice 11 12 vote on that, I ask to be recorded as no. 13 The Chairman. I appreciate that Senator. 14 This actually is semi-lateral, because there are several countries who are joining in, but not all, 15 16 clearly. There are some others in addition to the United 17 States, like the EU, Australia, and Canada. There are 18 some, but your point is well taken. 19 Is there any discussion? 20 Senator Carper? 21 Senator Grassley mentioned that he Senator Carper. supported the nomination of Carmen Nazario. I am pleased 22 23 to hear that. When she was before us, I introduced her, 24 and she served in a wide variety of capacities during my 25 administration as Governor of Delaware with great

- 1 competence. And I am pleased that you are going to
- 2 support her nomination.
- 3 You mentioned that there are some, I think, TANF
- data, that you are interested in obtaining and I just
- 5 want to offer whatever support and assistance I can in
- 6 making sure that you get what you need so that nomination
- 7 can go forward.
- 8 Senator Grassley. Yes. I would think that they
- 9 would be very willing to give us that information. I am
- not sure that I can tell you off the top of my head
- 11 exactly the specific problem we have, but it is
- 12 information that we need.
- 13 Senator Carper. Fair enough.
- 14 The Chairman. All right.
- The first order of business is S.J. Res. 17. Do any
- 16 Senators have any questions regarding the resolution?
- 17 Senator Grassley. Do you want me to make a motion?
- 18 The Chairman. Yes. As no amendments are filed, no
- 19 amendments are in order.
- Is there any further debate on the resolution?
- 21 The Chairman. All right. Currently, we are
- 22 waiting for them to come.
- 23 Senator Grassley. Can I make a motion at this
- point or do you have to have a quorum?
- The Chairman. We cannot act on it.

- 9 we are expecting them very shortly.
- 10 Senator Grassley. Yes.
- 11 The Chairman. They are "on their way".
- 12 One of those oft-repeated phrases in this body.
- [Laughter].
- 14 The Chairman. And to which the rejoinder is
- 15 always, on their way from where?
- 16 Senator Grassley. Yes.
- [Laughter].
- 18 The Chairman. All right.
- 19 There are issues we can go over now.
- 20 Senator Grassley. We can do some negotiation on
- 21 health care.
- The Chairman. Yes, we can. Yes.
- [Laughter].
- 24 The Chairman. Senator Kerry, you are a foreign
- policy expert. What can you tell us about Burma?

1	[Laughter].
2	Senator Kerry. It is a sad situation. My friend
3	Senator Enzi is accurate that it would be far more
4	effective if a lot more people were joining in, and
5	particularly if the Chinese had a different relationship
6	with Burma.
7	It is a shockingly disconnected government that has
8	only its own interests and money and power. So, it is a
9	sad situation. But, unfortunately, because of China's
10	close relationship, it has been very difficult for any
11	sanction to have a major impact.
12	The Chairman. All right. A quorum is now present.
13	Is there any further debate on the motion that the
14	committee report the resolution S.J. Res. 17?
15	[No response].
16	The Chairman. Seeing none, all of those in favor
17	say aye?
18	[A chorus of ayes].
19	The Chairman. Those opposed, no.
20	[A chorus of nays].
21	The Chairman. The ayes have it. The resolution is
22	ordered reported.
