We have data on how many consulting agreements each chair has. Though not under restrictions (and I agree Charlie has restrictions for a reason), no other chair has 6 consulting agreements. I am going to give data to Tom, along with the existing relationships between Solvay and dept in education and research for a clear discussion of the issues before he decides.

Our policy (like most in the country – just finished a discussion of this at national meeting) is that faculty may be granted up to 20% effort for private activities such as consulting as long as such activities contribute to the academic career of the individual and are (at least to some extent!) beneficial for the institution/dept/SOM. The 20% rule is not an entitlement. All agreements must be reviewed in advance and approved in Brenda's office before any faculty member is allowed to sign on, under policy. Charlie knows this. And Brenda knows about Charlie's restrictions, so she will speak with me if he puts a Solvay agreement through. I don't believe he has done so yet.

Once I have Tom's decision, I will have a talk with Charlie and present data and such.
