Thank you for your call today. Here is a summary of the items we discussed during our conversation.

- You asked if SCOP should present a slide deck for the informal discussion. I replied that you could submit any information that you want the MPSC to review in any format, but that it can be helpful for reviewers to refer back to information presented on a slide for reference.
- You discussed SCOP's search for additional information after this event (from blood banks and other sources). You voiced concern that this type of event may be a larger issue in the community. I stated that your presentation to the MPSC should primarily address the concerns stated in the Informal Discussion Offer letter and focus on the mitigating and corrective actions SCOP can take on its own to prevent recurrence of this event. Please save any larger community issues for the last minute(s) of the presentation or present this information separately prior to the discussion. If the MPSC feels that this issue is a larger community issue, they will address it as an educational referral to UNOS staff for further consideration.
- Feel free to ask MPSC reviewers for suggestions; they are your peers and they are available to you as a resource during the question and answer portion of the informal discussion.
- I stated that I believe with 90% certainty that the informal discussion will be on held on Monday, January 28th in the afternoon. Please arrange for OPO staff to be available for the discussion if possible. There will be more instructions in the scheduling letter coming tomorrow.

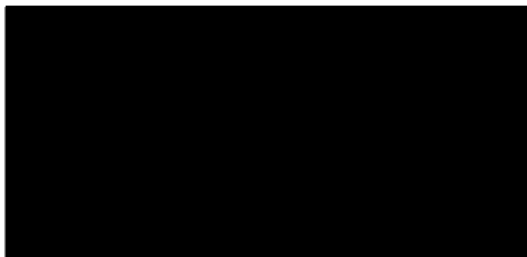

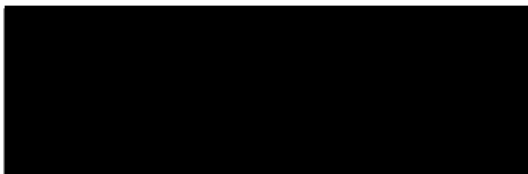
