Τ	OPENING STATEMENT OF HON. MIKE CRAPO, A U.S. SENATOR
2	FROM IDAHO, CHAIRMAN, COMMITTEE ON FINANCE
3	
4	The Chairman. The committee will come to order.
5	We meet today to favorably consider reporting the
6	nominations of Bryan Switzer to be a Deputy United
7	States Trade Representative; Gus Chiarello to be
8	Assistant Secretary for Financial Resources at the
9	Department of Health and Human Services; and Mike Stuart
10	to be General Counsel of HHS.
11	The meeting this morning will provide members with
12	the opportunity to offer remarks on the nominees, and
13	following any statements, we will recess briefly and
14	then proceed to this morning's hearing with Secretary
15	Kennedy. We will vote on these nominations off the
16	Senate floor today, and I think we've agreed to 11:30,
17	as there are other votes starting on the floor at that
18	time.
19	At his hearing, Mr. Switzer discussed his
20	commitment to trade policies and practices that place
21	the American economy and the American worker first. I
22	look forward to working with him, if confirmed, to
23	ensure that our trade policy prioritizes U.S.
24	competitiveness, spurs job creation, and promotes
25	innovation.

1	Mr. Chiarello and Mr. Stuart discussed the
2	critical issues in our health-care system, including
3	soaring costs, a burdensome drug approval process, and
4	the opioid crisis. If confirmed, both Mr. Chiarello and
5	Mr. Stuart will have the opportunity to advise Secretary
6	Kennedy on potential solutions. Given their respective
7	backgrounds, I am confident in their ability to provide
8	thoughtful counsel to the Secretary.
9	I will be voting in favor of each nomination, and
10	I encourage all of my colleagues on the committee to do
11	the same.

Senator Wyden?

1	OPENING STATEMENT OF HON. RON WYDEN, A U.S. SENATOR FROM
2	OREGON
3	
4	Senator Wyden. Thank you very much, Mr. Chairman.
5	I will start off with Michael Stuart. The Health
6	Department's top lawyer is responsible for calling balls
7	and strikes, making sure the Department follows the law.
8	That is something that Robert Kennedy and Donald Trump
9	have shown little interest in.
10	During his confirmation hearing, Mr. Stuart
11	provided the committee no assurances that he would
12	follow laws like EMTALA. That makes sure emergency
13	departments provide lifesaving medical care. Robert
14	Kennedy we will hear from him later today is
15	speed-running our country into the worse measles
16	outbreak in decades. He's gutted vaccine panels, cancer
17	research, and is overseeing the biggest blow to Medicaid
18	and the Affordable Care Act in history.
19	Mr. Stuart has given this committee no reason to
20	believe he would be anything other than a rubber stamp
21	for Robert Kennedy.
22	Next up, Gustav Chiarello, nominated to be the
23	Assistant Secretary for Financial Resources at HHS. If
24	confirmed, he will be responsible for the Department's
25	\$1.7-trillion budget. He does not have a single day's

1	worth of	experience	e managing	g the	finances	of	an
2	organizat	cion, let a	alone one	this	size.		

This is an important role, especially in light of the Trump administration's weaponizing of Federal funding. Between February's disaster funding freeze and Trump's latest rescission of funds that Congress already appropriated, the administration is making a mockery of congressional authority.

If confirmed, Mr. Chiarello would oversee unprecedented funding and staff cuts and budget shortfalls. He has shown no intention of pushing back against Donald Trump taking a blow torch to the programs and resources that millions of Americans rely on to stay healthy and safe.

Finally, Bryan Switzer, who is nominated to be

Deputy U.S. Trade Representative with jurisdiction over

Asia and a number of important areas: textiles,

investment, services, intellectual property. And from

Day 1, the reason this is an important appointment is

that Donald Trump's trade agenda has been disastrous.

His tariffs and trade flip-flopping have left
American farmers, businesses, and workers on an economic
roller coaster. Prices are up. Small businesses and
farmers struggle. For the sixth straight month in a
row, U.S. manufacturing has declined.

1	That is the message that I have heard all over my				
2	State, as I had town hall meetings in some of the most				
3	rural parts of Oregon, and talked with business owners,				
4	farmers, and ranchers. Mr. Switzer is going to provide				
5	neither transparency nor consistency, and I urge my				
6	colleagues to oppose him and to vote "no" on each of				
7	these nominees.
