Follow Up of Promesa Report No. 2 (The ones that Oppose to Everything)

Don't have the answer for the first three questions but I do for the last one.

The PROMESA board members need to understand the nature of the ones that oppose this program.

We all witness how they impede the PR Chamber of Commerce PROMESA meeting in the Condado Plaza Hotel on Wednesday, August 31. Using violence, physically attacking police officers, throwing rocks, breaking and damaging police vehicles, sometimes spreading water just to disguise when they threw urine to the guests. Many of the guests got to back off and walk away from the meeting. Probably, they will never, ever return.
