# OPENING STATEMENT OF SENATOR MAX BAUCUS, A U.S. SENATOR FROM MONTANA

Senator BAUCUS. The hearing will come to order. This is going to have to be compressed because we do not a lot of time. That is, there will be a couple of votes soon.

We are here to have a hearing to confirm some very capable candidates to important positions at Treasury and Commerce. The President has nominated Kenneth Dam to be Treasury Deputy Secretary, David Aufhauser to be General Counsel of Treasury, Michele Davis to be Treasury Assistant Secretary for Public Affairs, and Faryar Shirzad to be an Assistant Secretary of Commerce. And I thank all of you for coming on this date and being patient and waiting for us.

We have a strong tradition in this committee of promptly moving through nominees once the candidate's information is received from the White House and appropriate reviews are made. We now want to move forward very quickly and intend to vote on these nominations in the very near future. I think it is particularly important for the new administration to have senior officials in place as soon as possible. The nominees bring extensive experience and knowledge. And Mr. Dam has impressive credentials in government, academia, and corporate America. He was a law professor at University of Chicago. He once served as Deputy Secretary of State during the Reagan Administration. He is a man that the United Way turned to when a fundraising scandal rocked the public's confidence in the charity. His experience and intellect assured me that the second highest position at Treasury would be filled by a man who is very trustworthy, knowledgeable, and respected.

David Aufhauser has been nominated to be General Counsel. He will oversee more than 2,200 attorneys and 1,600 support staff, a job with great responsibility. His 23 years as a litigator makes him very qualified for this position at Treasury.

Mr. Shirzad has been nominated for the position of Assistant Secretary for Import Administration. He is no stranger to this Committee, having served with distinction as the Committee's International Trade Counsel.

Michele Davis will bring her Congressional experience and skills in communications to her position as Secretary for Public Affairs.

I am happy to support these nominations and look forward to working with you. I know I can speak for the entire Committee in saying that we wish you very well, and we hope you will be confirmed quickly and good luck. These are not going to be easy times.

I would like at this point for each of you just to say a word or two, getting to the heart of the statements you are going to make, and we will proceed that way, beginning with you, Mr. Dam.

## STATEMENT OF KENNETH W. DAM, OF ILLINOIS, NOMINEE TO BE DEPUTY SECRETARY OF THE TREASURY

Mr. DAM. Thank you, Senator Baucus, Senator Kyl. I have a statement, as you know, which I would like to submit, with your permission, for the record. And I would simply like to say that I am grateful for the opportunity to be here today and to appear before you.

Senator BAUCUS. Marcia, will you stand, please, so we can all see you? I will bet you are very proud.

I just simply want to say that if I am confirmed I look forward to working very closely with the Members of the Committee as well as with you, Senator Baucus, and Senator Kyl, and also with other people in the Congress. It will be a great privilege.

# STATEMENT OF DAVID D. AUFHAUSER, OF WASHINGTON, DC, NOMINEE TO BE GENERAL COUNSEL OF THE DEPARTMENT **OF THE TREASURY**

Mr. AUFHAUSER. Mr. Chairman, I do have a written statement and I will just submit it for the record. Just briefly, there is one thing I wanted to allude to in the statement.

When I interviewed for a job for Edward Bennett Williams more than 20 years ago he asked me what makes a good lawyer. And I quickly stepped into it and said "eloquence." He said, "No. You are wrong. It is the talent and the ability to listen. Only then do you know what to say.<sup>3</sup>

I am here to tell you that one of my pledges as General Counsel for Treasury, if confirmed, will be that I will listen to members of this Committee, to your staff, and to Congress, and try to respond to the best of my ability with good scholarship and good counsel both to you and to my now sole client, Mr. Dam here.

Senator BAUCUS. Thank you. Thank you very much.

Mr. AUFHAUSER. With the permission of the Committee, I would like to introduce my family.

Senator BAUCUS. Absolutely.

Mr. AUFHAUSER. My wife, Jane Tucker Dana, who is the smartest lawyer in the city.

Senator BAUCUS. Jane, do you want to stand? We want to see the smartest lawyer in the city. (Laughter.]

Mr. AUFHAUSER. My son, David.

Senator BAUCUS. David, why do you not stand too?

Mr. AUFHAUSER. If we appear before the Committee next fall, hopefully, we will report that he has made Eagle, having completed his Eagle project this summer.

Senator BAUCUS. Oh, super.

Mr. AUFHAUSER. My daughter, Anne, who was elected president of her seventh grade class, only to learn that they have term limits. (Laughter.]

Senator BAUCUS. Welcome to the world of politics.

Mr. AUFHAUSER. You may guess what her position is on the issue.

And my daughter, Kate, who has been bewitching all of us long before there was a Harry Potter.

Senator BAUCUS. Kate. Mr. AUFHAUSER. Thank you, Mr. Chairman. Senator BAUCUS. Thank you very much.

# STATEMENT OF FARYAR SHIRZAD, OF VIRGINIA, NOMINEE TO BE AN ASSISTANT SECRETARY OF COMMERCE FOR IMPORT ADMINISTRATION

Mr. SHIRZAD. Thank you, Senator Baucus, Senator Kyl. I do have a written statement that I would like to submit for the record.

I do have a fairly large contingent with me, so if you would indulge me.

Senator BAUCUS. This is great. All right.

Mr. SHIRZAD. I have my wife, Nancy; my son, David; my parents, Nasser and Parraneh Shirzad; and my siblings and my aunt and uncle in the second row there, all of who mean more to me than I think they know. And I appreciate the opportunity to introduce them.

Senator BAUCUS. Would you all stand, please? [Laughter.] All of you. The whole family. That is great. Thank you very much.

Mr. SHIRZAD. I do want to say, having served 3 years on the staff of the Committee, that I fully understand how important in all respects, but particularly in the conduct, the implementation, and the development of trade policy, how important it is for the President and the Executive Branch to work with Congress.

And my pledge to you, should I be confirmed, is to make good on what I have learned in the 3 years that I served up here, which is that we must work together to do what is necessary. And I appreciate the opportunity to do that. Thank you.

Senator BAUCUS. Well you are very, very welcome.

Senator BAUCUS. I have three obligatory questions that I have to ask all of you. And I will ask them en bloc.

First, is there anything that any of you are aware of in your background that might present a conflict of interest of the duties of the office to which you have been nominated?

For the record, I see four heads nodding that there is nothing. All right.

Do you know of any reason, personal or otherwise, that would in any way prevent you from fully and honorably discharging the responsibilities to the office to which you have been nominated?

Mr. DAM. No, sir.

Mr. AUFHAUSER. No, sir.

Mr. SHIRZAD. No. sir.

Ms. DAVIS. No, sir.

Senator BAUCUS. Third, do you agree, without reservation, to respond to any reasonable summons to appear and testify before any duly constituted committee of Congress if you are confirmed?

Mr. DAM. Yes, sir.

Mr. AUFHAUSER. Yes, sir.

Mr. SHIRZAD. Yes, sir.

Ms. DAVIS. Yes, sir.

Senator BAUCUS. Thank you.

I have just a couple of questions for you, Mr. Dam. Here it is the last week of March and next week we are having an important debate on the floor of the Senate about the budget and the size of the tax cut. And the President is very ardently pushing for his \$1.6 trillion tax cut, and what he campaigned on.

But one slight problem we have, we do not have any real details of the tax plan and/or of the budget. And I was wondering when we might expect to see the details of his tax plan. And, basically, because the Joint Tax Committee needs to see it, the specifications, to do revenue estimate of the plan.

Mr. DAM. Well, that is a serious question and I wish I could give a real answer to that. I will carry your message back. I am sure that everyone wishes to cooperate with you and provide you what you need. But I cannot speak to the details of your question.

Senator BAUCUS. I appreciate that. If you could take that back and speak with a little bit of forceful, earnest perseverance, that would be very helpful.

Mr. DAM. Good, Senator. Thank you.

Senator BAUCUS. Another question. There was a recent article in Forbes magazine entitled, "Are you a chump?" It is a cover story about tax avoidance schemes being pedaled to individuals and small businesses. And many of these shelters make extensive use of foreign entities, such as trusts and partnerships that make it difficult for the IRS to find.

And the article concludes that Americans are becoming more shameless about how they dodge the IRS and ever more confident the IRS cannot keep up with them. And since 1995, the number of IRS auditors has dropped 21 percent and a taxpayer's chance of being examined has dropped about 71 percent.

I would just like you to think about it. It is going to be difficult for a full answer at this point, because you have not been confirmed yet. But the question is, how can we assure Americans who are paying their fair share that they are not chumps? That they are being good Americans but too many Americans are not being good Americans. And maybe they are being taken advantage of and feel like they are chumps.

So how do we assure people who pay their fair share that they are not chumps?

Mr. DAM. Well, that is a serious question. I think it is important that all Americans pay their fair share and, particularly, that they abide by the law. And we certainly plan to enforce the law fully.

abide by the law. And we certainly plan to enforce the law fully. There are problems offshore. And, as you know, there have been various international efforts to make sure that people are not able to escape their taxes, and particularly American taxes.

But I do not know all of the details of this. But I take your point. And I will make this a priority to investigate. Senator BAUCUS. I would just encourage you to read the article. I was passing through an airport and saw Forbes magazine and there was the cover story. And I felt I am a ranking member of the Finance Committee, I had better read this thing. And it is an eye opener.

Mr. DAM. Right. There are, of course, various kinds of audits and various ways of ferreting out people who are evading taxes. But I take your point about the importance of audits.

Senator BAUCUS. A lot of this has to do with resources the IRS has or does not have. And I would just like to hear from you whether the Administration's budget will provide the IRS with sufficient resources, you think, to properly enforce our tax laws.

Mr. DAM. Again, I cannot give a full answer to that. I do know that the IRS computer budget has been substantially increased. There are also additions for positions to permit enhanced activity of the kind you are talking about. But I am not able to address the details because I was not involved in the budget process.

Senator BAUCUS. Sure. Well I appreciate this. But, you are right. These are very serious issues. And my guess is that several of us on the Committee will be inquiring about the degree to which the IRS is clamping down properly on those who cheat so that fewer Americans feel that they are not chumps. And I can just tell you now that this is something that I am going to be looking into. And so when we have future discussions I hope that we can get some solutions.

Mr. DAM. Well I want to assure you, we are going to give you all the information you need.

Senator BAUCUS. Thank you. And some recommendations too on how to solve them.

Mr. DAM. That and some recommendations. Thank you.

Senator BAUCUS. Thank you.

Mr. DAM. Thank you.

Senator BAUCUS. Senator Kyl.

Senator Kyl. Thank you, Mr. Chairman.

Just to make a point for those members of the families of these nominees who have, in some cases, traveled long distances to be here today. Let me assure you that while it may be somewhat disappointing that this hearing is not going to take a long time and that these four nominees will not be closely grilled in a lot of ways, while that may seem to be a bit disappointing to the four of them, I am sure it is not at all disappointing. They realize that next time they appear before the Committee they are likely to be grilled pretty extensively about one matter of another.

The reason that we do not need to take a great deal of time in this hearing to ask a lot of very difficult questions is, as the Chairman pointed out, all of these candidates have been vetted very carefully. And we have concluded that in each case there is certainly—that they are: (a) well qualified; and, (b) there is nothing in their background that would preclude them from serving. And, therefore, we do not need to stand on ceremony and take a great deal of everyone's time in quizzing them about things that really are not that significant.

The key thing here is that we have very qualified candidates. We appreciate the fact that they are proud of their families and that they would invite all of you to be here. And I think that the last point that the Chairman made is one that all of us can take from this hearing. And that is, that in all four cases we have very responsible people for very responsible positions and that each of us has an obligation to help all of the American people to understand what their rights and responsibilities as citizens are.

That includes, of course, paying their fair share of taxes. And for those who serve in the public, administering the laws as fairly and carefully and honestly as they possibly can. It is a reciprocal set of rights and responsibilities. We all take it very, very seriously.

of rights and responsibilities. We all take it very, very seriously. And I am just very proud that all of you could be here, those members of the family who are here, to participate in what is a very truncated procedure, but one which is actually very, very meaningful to the continuity of good government and the service of the people of America.

So we thank all you family members for being here. We thank the nominees for being here. And we do look forward to your early confirmation and then just grilling you all day long the next time you come before the Committee.

Thank you very much.

Senator BAUCUS. Well thank you very much, Senator Kyl. It is a very good comment. It also fits in, I think, with another probable fact, that is, you as the nominees and you as the families are with each other now. Once they are confirmed, you may not see very much of each other. (Laughter.] So take advantage of this while you can. And it is the awful dilemma that all of us in public service have, the balance between our job and family. And it is not an easy dilemma to resolve and easy to balance. But I know that all of you will do the best you can. And also both of you, in a very understanding way, recognizing both obligations and desires.

So I wish you well. It is not an easy task. But I thank you and I am so proud that all of you here want to take this on for the country. And we appreciate that.

I have just a couple of questions for Mr. Shirzad, and that is with respect to steel imports coming into this country. I would like your thoughts whether you will personally play a role in the Administration in deliberations over whether to initiate any anti-dumping investigations and what the appropriate remedy might be. This is becoming an issue.

Mr. SHIRZAD. If I am confirmed, Senator, obviously as the head of the Office of Import Administration, my job will be to enforce and to administer the unfair trade laws, the anti-dumping laws and the countervailing duty laws. I think there are about 150 pending orders in place now involving various types of steel products and a likelihood that more cases will be on the way.

I know very well from my time up here on the Hill and, frankly, from my time in private practice before that, the unique situation with the steel industry and the surge in steel imports that have come in since 1998 and again last year. And I will be very, very mindful of that as I administer my responsibilities, should I be confirmed.

Senator BAUCUS. I appreciate that. And the same applies also to softwood lumber imports coming into this country, particularly from Canada. Can we count on you to utilize your trade and legal experience to effectively and promptly enforce our laws against unfair trade, as this case proceeds?

Mr. SHIRZAD. Absolutely. I am very mindful of the fact that the softwood lumber agreement will be expiring very soon. And if pub-lic reports are accurate, cases will likely be filed as early as Monday. So I am eager for the opportunity to be in place, should the Senate see it fit to do that, so I that I can make sure that— Senator BAUCUS. Well I appreciate that, because this is of great

concern to many Senators, as I am sure you know. Mr. SHIRZAD. Absolutely. Senator BAUCUS. As is steel. We have got to advance quickly and

fairly and firmly on it because there are a lot of jobs at stake that would just be lost as consequence of dumping, in my judgment.

Well, I have no more questions. Just each of you, I just wish you very best luck. The hearing is adjourned.



#### PREPARED STATEMENT OF KENNETH W. DAM

Chairman Grassley, Ranking Member Baucus, and members of the Senate Finance Committee, I am grateful for the opportunity to appear before you today in connection with my nomination to be Deputy Secretary of the Treasury. I am honored that President Bush has asked me to serve in this important position, and I thank you for the privilege of appearing before you today.

Mr. Chairman, I have a deep and great respect for public service. And while I could not imagine the road my career would take when I grew up on a small farm in Kansas, among my other life experiences I have been most fortunate to serve our country and to make close friends during my years with the Federal Government. Here is how I arrived before you today:

After graduating from the University of Chicago Law School in 1957, I served as a law clerk to U.S. Supreme Court Justice Charles Whittaker and then joined a New York law firm. I became a faculty member of the University of Chicago Law School in 1960, and in 1971 I left to become Assistant Director of the Office of Management and Budget for national security and international affairs. After 2 years, I was appointed Executive Director of the Council on Economic Policy, responsible for coordination of U.S. domestic and international economic policy, under the leadership of the Chairman of that Council, George P. Shultz. I returned to the University of Chicago Law School at the end of 1973 and was

I returned to the University of Chicago Law School at the end of 1973 and was named Provost of the University in 1980. In 1982, I was appointed Deputy Secretary of State. After 3 years of implementing President Reagan's foreign policy initiatives, I departed for IBM, where I worked as a corporate vice president until 1992.

In 1992, I took a leave from IBM to serve, on an interim basis, as president and CEO of the United Way of America in order to clean up a scandal in that organization and to put into place a new system of controls and governance. Once I accomplished that goal, I returned to the teaching of law.

Members of the committee, this nomination appeals to me for three fundamental reasons.

First, I believe deeply in President Bush's vision for economic prosperity and security for our Nation. I strongly support the tenets of his plan: tax cuts that tear down the barriers to the middle class, debt reduction, and a secure Social Security system. In addition, I would like the opportunity to be an active advocate for the President, who understands our Nation's international role and its responsibility for a more open and vibrant world economy.

Second, I look forward to the prospect of working side by side again with my longtime friend Paul O'Neill. In a distinguished career, Paul has earned a reputation as a straight shooter, an innovator, and a deep thinker. I value his conviction and leadership, and I would be proud to serve with him again.

And third, I would be privileged to join the ranks of the Treasury Department, whose employees are known throughout government for their dedication and professional excellence. The Department boasts a rich legacy, and I hope to gain your agreement to allow me to be associated with that heritage.

#### Steel

*Question:* Given the importance of maintaining a strong domestic steel industry to the U.S. economy and national security, what options is the Administration considering to respond to the steel crisis?

Answer: Due to the concerns that you and others have raised, and because of the importance of the U.S. steel industry, the Administration has undertaken a comprehensive review of available options on how to address this issue, including consideration of the section 201 provision. This Administration has made clear that the vigorous enforcement of the unfair trade laws is vital to addressing the challenges currently confronting the industry. Currently, the office of Import Administration is responsible for more than 150 antidumping and countervailing duty orders, investigations and suspension agreements on steel products. If confirmed, I intend to place a high priority on effective enforcement of our laws and the expeditious handling of future cases.

### Bed Linens

*Question:* Recognizing the primacy of U.S. law, should the Commerce Department even consider revising its approach and significantly weaken our dumping law in light of this decision [Bed Linens] against a third country? Please explain how IA intends to address such practices (as seasonal dumping) in your answer.

Answer: Absent a decision directed at an action of the U.S. Government and our antidumping laws, nothing in the WTO compels a revision of the Commerce Department's current practices. As with any decision issued by the WTO, I will, if confirmed, examine thoroughly the specifics of the case and ensure that the United States has an effective response to any challenges to our practices.

Infmed, examine thoroughly the specifics of the case and ensure that the cluster States has an effective response to any challenges to our practices. With respect to agricultural cases, and with others that may involve the circumstances you describe, U.S. law contains provisions for dealing with targeted dumping, whether it deals with certain customers, particular time periods, or specific regions. If confirmed, I will enforce these provisions fully in accordance with the law.

### **Maintaining Strong Trade Laws**

*Question:* Can you assure me that our antidumping and countervailing duty laws will not be put on the table by the U.S. in any bilateral or multilateral trade negotiations? If you cannot so assure me, please explain why it is in our national interest to jeopardize one of our few remaining trade remedies to address dumped and illegally subsidized imports?

Answer: I want to assure you that I am a strong supporter of our trade remedy laws and that, if confirmed, I will oppose efforts to weaken these laws by our trading partners. I know well from my time as trade counsel to the Senate Finance Committee the importance of the trade remedy laws for addressing foreign unfair trade practices and maintaining support for trade liberalization.

### **China Safeguard Provision**

*Question:* In the event of market disruption, do you commit this administration to take strong action, pursuant to the terms of the agreement's product-specific safeguard, to limit Chinese imports as necessary to prevent such market disruption?

*Answer:* As you know, the China safequard provision is administered by USTR and the U.S. International Trade Commission. However, the importance of ensuring that U.S. industries and workers are not harmed by unfairly traded goods or market-disrupting import surges as China enters the WTO is a goal shared throughout the Administration. If confirmed, I will work closely with USTR to assist with the implementation of this provision.

# **Critical Circumstances**

*Question:* Can you assure me that I can count on the IA to provide domestic industries that are subjected to dumped and unfairly subsidized goods necessary relief via findings of critical circumstances where foreign producers flood the market with goods in anticipation of investigations?

*Answer:* I am fully committed to the strong enforcement of U.S. trade laws in accordance with Congress's intent. The critical circumstances provision is important to the effective administration of these laws and ensures that relief to the industry is not undermined by import surges prior to the preliminary determination. If confirmed, I intend to enforce this provision in accordance with the statute to ensure that the trade laws are not undercut.
