At the hotel adapters will be provided and wifi is free in your room. Also expect a small surprise from me and Mr Torshin.

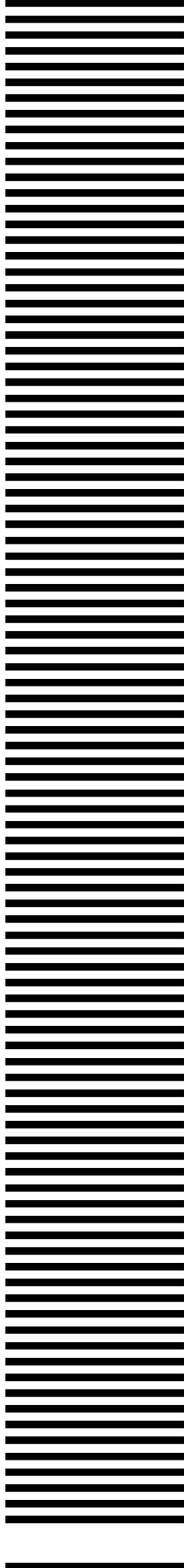
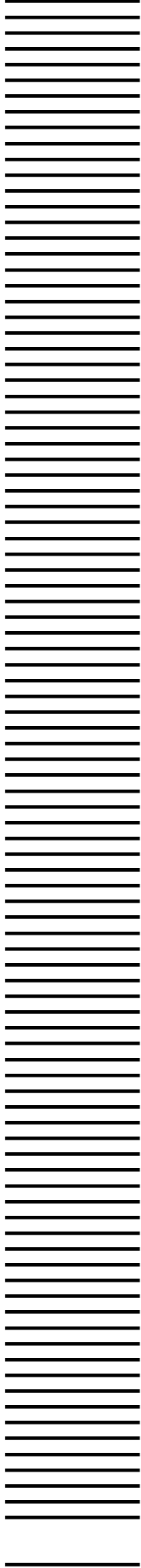

**Maria Butina – the Founder and board member of The All-Russian Public Organization “The Right to Bear Arms”; the special assistant of the State-Secretary-Deputy Governor of the Bank of Russia Alexander Torshin.**

Mrs. Butina was born in 1988 in Altai Region (southern Siberia, Russia).

She received twin Masters Degrees in political science and education from The Altai State University in 2010 in her hometown of Barnaul, Altai Region, Russian Federation. She is a candidate for a PhD in 2015 – her dissertation is focused on the challenges of political organizations as alternatives to traditional political parties.

Butina launched a small chain of furniture stores in her hometown of Barnaul after graduating from college and was the executive director of her local International Rotary Club.

Maria Butina was named the founding Chairman of “The Right to Bear Arms.” This organization was created in 2010 as one of the last wishes of Gen. Mikhail Kalashnikov (the inventor of the AK-47).

Maria is the co-author of multiple reports on potential reforms of Russian weapons law. Her reports have been published under the auspices of the upper house of the Russian Parliament (the Federal Assembly – the Russian Senate) and are a synthesis of other countries’ experiences with such reforms.

She is a member of the international shooting organizations IPSC and IDPA and is a certified judge for the International Practical Shooting Confederation.

Butina is an owner and CEO of “Antares, LLC”. Focused in public relations and advertising in Moscow, Russia.

Maria is a public speaker of The Right to Bear Arms and an expert in weapons, civilian gun rights and self-defense.

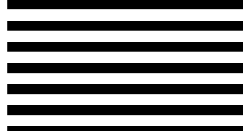


#### **Oleg Gladkikh – major investor of “Artemida” group of companies**

**1:15 – 5:00 PM – The Visit to Vyatka-Polyansky Engineering Plant “MOLOT”**

Vyatka-Polyansky Engineering Plant “MOLOT” - one of the oldest enterprises of the Kirov region. The official date of foundation - April 26, 1940. That same day, the plant number 367 hardware IEC USSR Zagorsk Moscow region evacuated later in Vyatskiye Polyany, was handed over to the system of the USSR and the People's Commissariat of weapons at number number 367 and became head of production of the famous PCA - SMGs design famous Russian gunsmith GS Shpagin.

Today, "MOLOT" - a well-known brand under which made hunting and sporting guns, known for its high quality and high performance characteristics in virtually all countries of the world. One of the main activities of the plant is still producing military equipment and products. Also, under the name "MOLOT" and produced civilian products - it's gas, packing equipment and consumer goods.

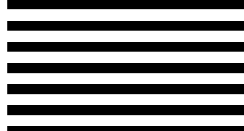
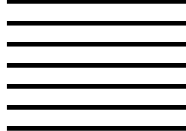
ORSIS is the trading name of Promtechnologies group based in Moscow, Russia. Specializing in the manufacture of centrefire rifles designed for a variety of military and civilian applications, ORSIS was founded in 2011 and is owned entirely by private investors. The company launched with the T-5000 tactical rifle, before releasing a number of civilian derivatives for both hunting and long range target shooting. The company is able to produce entire rifles, including stocks, actions and barrels, as well as being able to produce replacement barrels for third party firearms.

In 2012 ORSIS entered a joint venture to perform final assembly for a number of Glock products. Later the company has been started the production of AR-15.

**1:00 – 6:00 PM – The Visit to TsNIITochMash in Klimovsk**

TsNIITochMash is an initialism for the Central Research Institute for Precision Machine Building, a Russian industrial design bureau. TsNIITochMash is a major designer and producer of weapons for the Russian military and MVD Internal Troops.

TsNIITochMash determines the development of and develops small arms and simulators for them, individual field equipment, conducts R&D on control systems for precision-guided munitions (as well as protection against them), field artillery



systems and new materials. It also develops most cartridges, from small arms up to 14.5 x 114 mm, for the Russian Army.
