1	OPENING STATEMENT OF HON. RON WYDEN, A U.S. SENATOR FROM
2	OREGON, CHAIRMAN, COMMITTEE ON FINANCE
3	
4	The Chairman. The Finance Committee meets this
5	morning to vote on the nomination of Mr. Doug McKalip to
6	serve as the Chief Agricultural Negotiator within the
7	Office of the United States Trade Representative.
8	Obviously trade is essential to our country, and to my
9	State, something like one out of four jobs revolves
10	around international trade. And the trade jobs often pay
11	better than do the non-trade jobs because there is a
12	value added. And we do a lot of things well in Oregon.
13	What we do especially well is we grow things.
14	And I know Senator Crapo feels very strongly about
15	this whole question of agriculture in the Northwest
16	for example, potatoes, and other agricultural products.
17	So, this is an extremely important position.
18	And Mr. McKalip is certainly qualified for this job.
19	He has been a public servant for nearly 30 years in
20	roles focused on ag policy and helping rural America get
21	ahead. He is currently a top advisor to Agricultural
22	Secretary Vilsack on trade, ag safety, national security
23	and a host of other issues.
24	His experience includes several other leadership
25	positions at the Department of Agriculture and with the

- Domestic Policy Council. There's no doubt that he'll be ready to step in and succeed as Chief Ag Negotiator on
- 3 day one. He is going to be busy.
- 4 These days Americans are paying more for their
- 5 groceries but getting less, and our farms and ranchers
- 6 are getting clobbered by inflation and drought.
- 7 Americans are not alone in dealing with these crises.
- 8 Amid a pandemic, war and climate change, food is in
- 9 short supply around the world.
- 10 Smart trade policy is one important solution to
- 11 hunger in the 21st century -- a policy that promotes
- 12 affordable, abundant food here at home and abroad. The
- policy has to lower costs for farmers, bust through
- 14 trade barriers and help distribute more American ag
- exports.
- Mr. McKalip will lead these efforts as our top ag
- 17 negotiator. He will also help address other key issues,
- 18 including areas where trade enforcement needs a boost.
- 19 For example, Canada is propping up barriers to our dairy
- 20 products. Mexico is unfairly blocking American-grown
- 21 corn and soybeans. The Trump administration negotiated a
- flimsy agreement for the Chinese government to buy more
- 23 American ag products, but China is bringing in only a
- fraction of the totals it agreed to.
- 25 Mr. McKalip is a strong choice to take on these

- challenges as our top trade advocate for American
- 2 agriculture. He has fans on both sides of the aisle. We

- 3 expect to work closely with him once he is confirmed.
- 4 I urge all my colleagues to support him.
- 5 And let me now also go through the procedure for the
- 6 morning, because it is a hectic day following our August
- 7 recess. We have got many committees conducting
- 8 business. Ours is no exception. And having consulted
- 9 with Ranking Member Crapo, here is how we are going to
- 10 proceed this morning. And I have made my opening
- 11 statement and will be followed by Senator Crapo.
- 12 If there are any other Finance members who wish to
- make statements, at that point we are going to recess
- 14 until the next roll call vote on the Senate floor, when
- 15 the Committee will reconvene in the President's Room off
- 16 the floor to have the vote.
- 17 My understanding is, this process is acceptable to
- 18 you, Senator Crapo.
- 19 Senator Crapo. Yes.
- The Chairman. Very good. I have made my opening
- 21 statement. I urge my colleagues' support for Mr.
- McKalip.
- 23 Let's hear now from Senator Crapo, and any other
- 24 Finance members who would like to be heard from.

1	OPENING STATEMENT OF HON. MIKE CRAPO, A U.S. SENATOR

4	Senator Crapo. Thank you, Mr. Chairman. Today we
5	are voting on Doug McKalip, a nominee who if confirmed
6	will play a critical role in opening opportunities for
7	our farmers.
8	Our farmers need these opportunities more than ever
9	in the face of record inflation. I intend to support
10	him. Although I am disappointed that the Administration
11	has not prioritized agricultural market access,
12	including by taking too long to fill this position, I
13	appreciate that the nominee recognizes the importance of
14	opening foreign markets to our farmers.
15	Moreover, Mr. McKalip has extensive experience in
16	agricultural issues. I agree with the observations made
17	by our Chairman, and I thank you, Mr. Chairman, for
18	holding this Executive Session today.
19	I yield back to you.
20	The Chairman. I thank my colleague. I at this
21	point recognize that we do not have any additional
22	Finance members in attendance. So, we will stand in
23	recess, subject to the call of the Chair. Finance
24	members will be notified once the time and location are
25	determined for the continuation of today's markup. And
