

**Results of Executive Session
July 18, 2012**

Enforcing Orders and Reducing Customs Evasion (ENFORCE) Act

Amendment #2, (Hatch #1): U.S. Customs and Border Protection Reimbursement Pilot Program for User Fees for Customs Service at Airports, Seaports and Land Ports. Withdrawn.

Amendment #1, (Stabenow #1): Protect American Innovation Act. Withdrawn.

Final passage: Approved by voice vote.

Citrus, Cotton and Wool Trust Funds

Amendment #13, (Kyl #1): To reform the process for considering miscellaneous tariff bills. Failed by voice vote.

Amendment #1, (Wyden #1, as modified): Transparency and Consultations with Congress on Trade Negotiations. Withdrawn.

Amendment #17, (Crapo/Snowe #2, as modified) : To improve trade dispute resolutions with Canada concerning cross-border trade and timber products. Amendment accepted without objection.

Amendment #19, (Thune #1): An amendment to provide for temporary Trade Promotion Authority. Failed by roll call vote, 11 ayes, 13 nays.

African Growth and Opportunity Act (AGOA) Amendments, Dominican Republic – Central America – United States Free Trade Agreement (CAFTA-DR) Technical Corrections and Burma Sanctions

Final Passage: Approved by voice vote.

Russia Permanent Normal Trade Relations (PNTR) and Moldova PNTR

Amendment 31, (Cornyn #1): Create Magnitsky Sanctions for Enablers of Mass Atrocities. Withdrawn.

Amendment #32, (Cornyn #2), as modified to apply only to Syria: Delay Effective Date Until Certification on Cessation of Arms Transfers to State Sponsors of Terrorism. Failed by roll call vote, 8 ayes, 16 nays.

Amendment 25, (Schumer #1): Russian Compliance with Information Technology Agreement Accountability Act of 2012. Withdrawn.

Amendment #26, (Menendez #1): To ensure the enforcement and protection of intellectual property rights in Russia through enhanced reporting requirements. Withdrawn.

Amendment 29, (Kyl #1): To include reporting on outreach in the Commerce Secretary's annual report about the anti-corruption hotline and website. Accepted by voice vote.

Final Passage: Chairman's Mark, as modified, approved by Roll Call Vote, 24 ayes, 0 nays.
