I have been working my daughter's whole life to make sure they have the opportunity to "Live The American Dream!" The girls were born in the mid 1960s when girls had to fight to be seen as equals to the boys......early on we found we had to work a little harder because my first daughter, Kandi, was diagnosed with a moderate intelligent disability when she was 2 years old. I was told to take her home and love her! A young Mom, with a 2 year old daughter and a 6 month old daughter, Kristi, and a heart that didn't guite know what to do with this new information in 1966!

The years have flown by but the fight continues for my daughters to Live The American Dream. They both started school the same year in Kansas where we lived.....soon Kandi was moved to a Special Education Center where she was in a TMR class (trainable mentally retarded - thank heaven we don't use those words anymore). Her sister continued in our neighborhood school and excelling at every class she was in. Kristi was now the oldest by default. We worked to get Kandi included in the typical school not a special education center!

The girls graduated from high school the same year. Kristi prepared to go off to the University of Kansas. Support Kandi received was paid for, in the 1980's, by county money, state money and what agencies could fund raise. Medicaid money went to institutional settings. Kandi wanted to move out of my house when she saw her sister leaving for college. So she moved into a residential setting....

Then County money ran out and State money became less, Kandi lost her funding for supports - she was not going to be able to continue in her vocational program or her residential home. I was told she either had to come home or go to an institution where Medicaid would pay for her supports. She didn't want to move home and do nothing (I worked and it would have been hard to find help while I was at work). I just couldn't send her to an institution so I called a friend who was the executive director of a DD agency about 100 miles from where we lived....Kandi could move there and continue to receive supports....now to fight for Medicaid money to be used in the community not only in institution.....Kandi wanted to live the American Dream in her community.....her sister had graduated from college, had a job and her own townhouse. Kandi wanted the same, her house and a job! But Kandi will always need long term support because of her disability. She wants the American Dream!

We won the fight for Home and Community Based Services - a State and Federal partnership happened Children and adults with disabilities could stay in their communities with family, go to school with their peers and as adults live in their own place.....work in their community. Medicaid is not just health insurance, it's a lifeline to long term support, in the community, it's the American Dream for people with disabilities! Kandi works for Fry's Food Stores and has for over 8 years (she gets supported employment support through HCBS), she lives in a townhouse with HCBS support.....she has the American Dream like her sister!

We have fought the fight in the past, we fight this fight in the present - Graham-Cassidy is not the answer to healthcare and long term supports.....it will rip my daughter's American Dream out from under her and other children and adults in the community! We can find an answer to Healthcare and long term supports is we listen to each other and work together...Congress needs to get back to what they should be doing......representing us!

For the last 41 years, I have devoted my life's work to helping people with Developmental Disabilities. I started in the institution and am now happy to say, most of our members live in community homes. All of our progress in this important field has come about because of Medicaid. Without this funding, these life enhancing changes would not have been possible. These services include residential, day and employment programs, in-home family support services (attendant care, habilitation, respite, etc.). Also included are all the acute care and behavioral health services our member's receive.

Repealing of the Affordable Care Act will have a serious, negative impact on services. After a few years, the currently proposed bill (Graham) will dramatically reduce Medicaid funding to states, thereby removing the gains we've made in this field. Because of these funding issues, I see a strong possibility that state may move back to institutional placements. In addition, the federal mandate to require states to 'do the right thing' will be lost. States will be allowed to turn their backs on the poor and disadvantaged and allow insurance company to raise rates, effectively pushing people out of coverage.

This bill is mean-spirited and our public representatives (House and Senate) should, firmly and flatly, reject it! Simply dumping a lump sum (aka. block grant) of money on states and turning their backs on how Americans are treated is not what our leaders were elected to do. Instead of trying to ruin the ACA (removing the core elements that would make it effective (market place)), congress should support it and work together to correct the problems. Our country is watching!!

Hello, My child was born with Down syndrome, visual impairments and 4 yrs ago was diagnosed with Autism and seizure disorder. Without the help of medicaid, I do not know how we would make it through. Between the 5 therapies a week, a school funded by the state by medicaid and the unusual number of illnesses that continue to surprise me and he ends up in the ER or the hospital. I know that we are eternally grateful for the services that we are getting. If you were to take those away, I as a single mother whom works a part time job to take care of her son would not be able to substain the life that we have. I am one of the 44 % that is below poverty level. I barely qualify for services as is because they say that I make too much money. I am lucky to bring home perhaps annually about \$ 16,200.00. If medicaid would be cut, I would then have to pay over \$ 1220.00 a month to have health insurance on my son and I. Then we have the deductable that the insurance company states that I have to meet. An astronomical amount of \$ 18,000.00 before my insurance would kick in to pay for any of medical. Heck, I do not even make this much a year but, now I will be required to meet. This does not include the cost of daycare, let just ballpark figure it to anywhere from \$15.00 to \$ 20.00 an hour. because let's face it. These children do not function well outside their comfort zones. A regular daycare center is off the table...I would be working just to cover the medical and daycare expenses. What about housing and food. Those are essentials are they not. I am sure that I am not the only parent that has found themselves in this predicament. I am a highly educated woman with a college degree whom has decided to put the needs of her child first. We are just asking that you look at the picture as a whole and not through rose tinted glasses..

As a disabled life-long Arizonan now living in California, I've not only experienced the relief of having Medicaid after decades of no healthcare, I've also experienced no healthcare and no way to get it. And I live my daily life dealing with pain and disability that could have been prevented or reduced if I'd had life-long healthcare.

"I hope I don't die from this" was a frequent refrain, and now that I do have healthcare, and have been diagnosed to discover my complex and overlapping medical conditions, I am utterly terrified of going back to having no healthcare atall due to what will then be a pre-existing condition. Because I was able to finally get help for it.

I'm even more afraid of healthcare cuts to Medicaid in Arizona because my parents live there. They have been straight ticket Republicans for my entire life. They have also been without healthcare most of my life. And mom is suffering the end stage results of that lack of care with a failing heart and kidneys, her vision already lost to her pre-existing autoimmune disease.

They subsist on Social Security and are drowning in medical bills for mom's emergency care and the medicines they need to stay alive.

On the bright side the ACA has provided them some relief and while mom is in a care home, she now has better and more compassionate care than she had before. That's still no substitute to the quality of life she lost before ACA could have helped her.

As Senators, you all have excellent health care and screenings for life, so I'm sure you can't imagine what it's like for a disabled Army vet (my dad) who now has good healthcare from the VA to helplessly watch his wife die by inches. He's been at her side in the Home's dining hall every night since she's been there.

The staff think they're sweet. The truth is, as sweet as they seem, after almost 55 years of marriage they don't know how to be apart.

Dad doesn't know how to live on his own, but in-home support services are helping. Not just him, but countless others like him.

We need to plug the gaps in the ACA, not tear gaping new ones.

Please vote with your compassion for your fellow human beings in suffering. Not with your corporate friends, sponsorships, or investments. Or how can you claim to represent all of us if you leave the least of us, the tired and poor, behind?

I am a resident of Arizona and am writing to express my deep concern over the extreme cuts to Medicare proposed by the Republican leadership in the Senate. These cuts are beyond cutting ACA increases and would negatively impact the most vulnerable of society and those who serve them.

My niece is totally and severely handicapped. She is unable to live independently and provide any of her own support or income. Consequently she has no employer benefits and currently receives all medical care and her day care program via state managed Medicaid benefits.

These benefits are essential not only to her well being but to our family who care for her and have for over 30 years.

Caring for an elderly or disabled family member, for a few years or many years, is a great financial, emotionally, and physical strain. I work in mortgage banking and have read the stories of several people who had to give up jobs, savings and good credit to care for a family member without insurance or income. This is a huge drain on our economy. Deep cuts in Medicaid put jobs, savings, and future economic well being at risk.

I and 72 years old and my wife is elderly as well. We have a 46 year old son who is mentally handicapped and he will live with us until we die. We continue to be very active in his ;life as he has worked at the local Mohave County ARC since the time he graduated from High School. We are also very active in the ARC volunteering at the ARC and I am also the President of the MCARC Board of Directors. MCARC has been very valuable to this Community for more than 40 years and there are numerous clients there who have worked there for more than 30 years. We currently have 32 clients who are part of the program. There are several of them who work there and the pay is their sole means of income other than the Medicaid benefits they receive for Health care. But the vast majority are solely dependent on the Arizona State benefits that help pay for the support of MCARC. It would be a devastating blow to take away their benefits as many of them are elderly and their parents have already passed away so they also need additional care for living. It is sad that the majority of our Politicians care more about taking money away from the wealthy people in this Country

than they do about the hundreds of millions of other Citizens in this country. This is particularly true here in Arizona both at the State and at the national level.

Dear Senator Flake and Senator McCain,

I want to introduce you to my wonderful 25 year old daughter, Sydney.



Sydney is a bright and funny young woman who happens to be autistic.

She loves puzzles, trivia, and she is a voracious reader.

(She is quite well-versed in famous Supreme Court cases if anyone ever needs a quick fact-check.)

Medicaid Medical Care: When Sydney was a baby, we had a family situation that resulted in a change in health insurance.

We were devastated to learn then that her father's new insurance plan would not cover our daughter due to "**pre-existing conditions**".

Thankfully Sydney did qualify for Medicaid and she has had her medical care provided through AHCCCS ever since.

Sydney as a child experienced the normal childhood medical needs but also struggled with Epilepsy and Juvenile Rheumatoid Arthritis.

These medical conditions were covered and she received good care with ongoing medical treatments provided through **Medicaid/ AHCCCS**.

With appropriate preventative care – Sydney's seizures were stopped and she has been seizure-free for many years due to Medicaid provided healthcare.

Medicaid Therapy and Early Interventions: Due to our daughter's early language delays and other developmental challenges,

Sydney received early interventions in the form of **Speech**, **Physical**, and **Occupational therapies** ... provided through Medicaid.

Our bright daughter made incredible advances with these interventions to the point that she was fully included in her general education classes

throughout her schooling in Arizona's public education system until she graduated from high school.

We are two working parents and have another child: Sydney's hero ... and older brother, Cameron (now an Arizona high school math teacher).

Providing for Sydney's needs has been challenging.

Without the **medical care and interventions provided through Medicaid**, I cannot imagine how we could have managed and I cannot imagine the unnecessary

limitations our daughter would have suffered.

- Would Sydney have achieved the life-altering improvements in language and functioning skills without the early interventions that we could not afford to provide?
- How much damage to her brain would have happened with continuing epileptic seizures without proper preventative medical care?

Employment / Vocational Rehab: Sydney now has a goal to be employed in her community. She receives **Vocational Rehab** services to help her gain the skills that she needs.

Medicaid Independent Living Supports: At this time, Sydney also receives supports to make it possible for her to live independently in her own apartment.

With Medicaid supports, what seemed like an outlandish and extremely unlikely dream in her early days is becoming a reality.

Through Medicaid, Sydney receives in-home and community supports to assist her in her daily needs and to help her achieve her goal of a safe independent life. Sydney understands that though her parents love her beyond words,

we will not always be able to provide the kind of support and care that she needs.

She is working on the skills she needs to reside safely in her own home.

Without her Medicaid supports, Sydney would be unable to safely live in her own home and would eventually need to move into a group home.

There are many troubling aspects to this new "health care" bill and the CBO has determined that it puts many critical Medicaid services at risk.

Please **do not dismiss** the CBO findings. There are real people ... real families ... depending on your honest and compassionate, clear eyed acknowledgement of the devastating faults in this bill.

We urge you to do the right thing for your most vulnerable constituents ... and **vote NO** on this "health care" act.

If you knew our Sydney, we think you could only in good conscious vote one way. Preserve her healthcare. Protect her Medicaid services. Defend her right to a life of dignity.
