I gave up my full-time job to take her to all her therapies--occupational therapy, physical therapy, an inclusive preschool, plus therapeutic horseback riding. My husband gave up his lunch break in order to take her to swim several times a week. We both take her on walks in her walker or gait trainer. I fit in a few hours a day to work from home. But it isn't enough to afford all that she needs. Medi-Cal makes it possible for us to afford insurance that gives her the therapies AND the medical equipment that she needs.

Medicaid has saved my life and my son's life. I am here to defend it and fight for its expansion.

I was born with cerebral palsy that gave me a speech disability and a physical disability.

With the exception of when I was first born, healthcare became absolutely critical to me was when I became pregnant with my son at age 24. I needed special prenatal and postnatal care. Because I had a disability, my doctor made me come in every week during the first part of my pregnancy because I was considered high risk. So my health bills were really expensive.. luckily these were covered by Medicaid. When I went into labor, my water broke like normal but I wasn't dialating and so they had to induce me using medicine. This allowed me to give birth to my son, Brandon.

When Brandon was one, we discovered he had a hole in is heart. This was the 2nd time that healthcare became absolutely critical to me. He needed open heart surgery to close the hole and prevent his heart from getting weaker and weaker. After the surgery, he needed to stay in the hospital for an entire week to recover. While this was successful, Brandon has other chronic health problems such as seizures and diabetes that needed ongoing care.

If I didn't have healthcare provided by Medicaid at these points in my life, my family would have suffered financially and both my son and I might not be here today. For this reason I am here, to tell Senator Heller and all of the Senate why Medicaid is so important and why it needs to be expanded, not cut.

Medicaid has been absolutely critical to my life in another way. It has paid for attendant support with activities of daily living such as dressing, cooking, and going shopping, which has enabled me to live independently. Without attendant support, I would have likely been placed in a nursing home where I would have had very few choices in my life. Medicaid funded attendant support has made it possible for me to attend college, raise my son and run my business.

I call on the Senate and Congress to get the courage to defend Medicaid against attack and to strengthen the program so that my son will have the healthcare he'll need his entire life to be healthy and so that millions of people with disabilities like me will have the homecare we need to live our lives on our own terms.

I am writing to express my opposition to the Graham - Cassidy bill that will come before the senate in the next week or so. My wife and I have an adult son that is deaf and intellectually disabled. He attends an adult day program, called Deaf Plus Adult Community (DPAC), in Newark California. His program is highly dependent on Medicaid. I am a registered Republican and I support the administration's efforts to reduce waste in government, but this is one area that we know well and do not see waste. On the contrary, we see dedicated people working with limited resources to support a program in a very high cost of living area. DPAC is a lean program that is supported by the California State Regional Centers. This program supports 30 adults that are deaf or deaf and blind and have intellectual disabilities. They employ ~18 people of which 14 are deaf. Not only do they give the adult clients a life of learning and community engagement, they also employ a large number of deaf staff that have an extremely challenging time to find employment, even in the San Francisco bay area. They do all of that with less than \$1M / year of funding support through Medicaid. Without Medicaid funding this program will be forced to close and those 30 individuals will be a burden to their families until their parents die and they are forced out into an uncertain and likely ill equipped community.

Please don't throw the disabled out with "the bath water" as you work to improve health care in the US!

She was hospitalized, tested for several illnesses and the doctors chose to diagnose her with Metachromatic Leukodystrophy, a degenerative brain disease, although all tests for it proved negative.

A gastrointestinal tube ("G-tube") was inserted into her stomach for nutritional and medicinal purposes and the doctors sent her home for me to love with six months to live. Needless to say, she surpassed the doctor's prognosis and within a year she started kicking her legs and moving her arms a little. She was still unable to eat with her mouth and lived on a formula called Pediasure followed by several medications including valium, chlorohydrate, baclophen, and Ritalin, to name a few. Her diagnosis was changed to a spastic quad with severe cerebral palsy.

Public schools were a nightmare and our homeschool adventures began when Veronica was ten years old. She was unable to speak clearly and was roughly communicating with her Dynavox and she had confided to me that a horrible incident had happened to her at her school, and she said if she talked, "he would kill her". Her first words to her pediatrician mentioned his name and what he had done to her. Her pediatrician immediately suggested that I homeschool her. And so I did!

I didn't even know that I could, legally. I was scared at first, but I found a homeschool group on a website and started asking questions. This group was extremely helpful and many of the members offered their individual experience and knowledge. They gave me the courage and confidence I needed. During this time we've been homeschooling, Veronica has learned various computer, reading and writing skills. She loves to write, and journals every morning before we start schoolwork. I provide speech therapy, just by talking with her, and I am able to understand the speed of her processing skills. I've learned to keep everything simple with lots of repetition, jokes and humor. I also provide physical and occupational therapy. I walk her with a gait trainer; (a special walker w/support for upper body), and we exercise her arms with various stretches, such as feeding the dogs treats over the balcony.

We have a little Terrier named Ziggy that we've taught to say, "HaaRow", before he gets a treat.

Veronica giggles and giggles! We have so much fun! She also uses her arms to pull herself and her chair around the balcony and back. I've taught her about her body and how eating healthy affects her health and happiness.

Oh, yes and Veronica is free from any medication, and the "G" tube was removed three years ago. Although she is unable to hold a cup, she can drink through a straw and feed herself with supervision.

As I mentioned before, without In-Home-Support-Services, I honestly don't know where we'd be today. Through my consistent love and support as a mother and 24 hour caregiver, Veronica continues to progress in all areas. She's still afraid of men and terrified to be left alone. Veronica and I now have great verbal communication, and a friendship that I never thought possible! She tells me every day how grateful she is to be homeschooled and how much she loves to stay home with me. She tells me that we have a great life and I'm a great mom. Most of all, Veronica is safe and happy!

I am a licensed Marriage and Family Therapist and my practice serves the "special needs" community of children, teen and adults who have Autism, Obsessive Compulsive Disorder, Tourette Syndrome, social anxiety and Attentional issues.

Approximately 1/2 of the 92 clients that we see weekly are on medication for the behaviors that interfere with their lives, at home, school and in the community. 75% of those on medication cannot afford the \$325-\$400.00 per hour that a child psychiatrist charges per session or the \$175.00-\$250.00 they charge for a 20 minute medication follow up here in the San Fernando Valley of Los Angeles. They ask me if I know any doctors that take Medicaid and I know of only 2 locally that do, but there is a list of specialists they can access.

Without being able to access Medicaid for help, these citizens will have to be kept at home; parents cannot leave them to go to work and eventually these families, may be homeless if they cannot leave home for a job. The population I started seeing 21 years ago are all adults now and receive some services through the Los Angeles County Regional Centers but medication is not included in the multiple services they do fund.

This is a larger population needing Medicaid than most people know if they do not have a child or dependent adult with developmental disabilities, special needs or Behaviorial issues (the aggregate of responses to internal and external stimuli.) Please do not put them, their families or the community at risk by taking away any benefits they derive from Medicaid.

I grew up in San Francisco, and also attended UC Berkeley,

When I was three-years-old, a couple of years before I moved to San Francisco, a doctor told my very young, single mother I would never be able to do much of anything. With a great deal of help from my mom and all the other people she calls my "village," I was able to prove that doctor wrong. The support of Medicaid has been critical to my success. I have relied on Medicaid funding for the Home and Community-based caregiving support that enables me to live a full and productive life in the community, instead of in an institution or nursing home. (Or in my case, since my family would have done everything possible to keep me out of a nursing home, Medicaid has allowed them to have full and productive lives, and there wasn't an undue financial burden on them.) I was able to attend UC Berkeley because I had someone getting me up each morning, dressing me, taking me to the bathroom, etc.. I was also able to provide disability awareness programs to thousands of students in the San Francisco Bay Area because of Medicaid provided attendant care. As I have advocated to help domestic workers (like attendants) to get overtime and other worker protections, I have done so with the help of Medicaid funded attendants. In 2011, when President Obama announced a regulation mandating minimum wages and overtime for in-home care providers, I was invited to participate in his announcement at a White House press conference, and of course wouldn't have been able to be there without my attendant.

My mother had to forgo getting married for fifteen years so that we could remain poor enough for me to qualify for Medicaid, in order to pay for my wheelchairs, other equipment and medical treatments. She saw the huge challenges faced by families who did not qualify for Medicaid, but who couldn't get insurance for their disabled children due to their pre-existing conditions. However, her choice was also a hardship, since she had to go without her own health insurance until she was finally able to marry my step-father and obtain coverage through his employer, once I reached adulthood and could qualify for Medicaid on my own. This pre-existing condition problem was solved by the ACA, but now threatens to become a huge problem again.

In 2013, I checked into UCSF for five days to begin chemotherapy for lymphoma. I was supposed to come back every 21 days for six treatments total. Unfortunately, because of my disability, everything went terribly wrong, and I was in the hospital for a very costly five months, instead. If there had been a cap on Medicaid, my family would have gone bankrupt... or I could have just died. A Medicaid cap is a real "death panel."

When I was chairperson of the California State Council on Developmental Disabilities, we talked about how to EXPAND Medicaid-based attendant care because too many people with disabilities who need this assistance are still not covered. As you saw during the protests in the Summer at Senators' offices, disabled people who need attendants and other Medicaid provided health care are terrified of what comes next. We do not want to be forced into nursing homes or other institutions, like in the bad old days before the disability rights movement. I urge you to vote no on this horrendous bill! One is a young woman who is blind, deaf, non-verbal and unable to walk due to the low level of her cognitive functioning. Medicaid funds are so limited that California children's services will not pay for both a heavy style wheelchair and a lighter easy to transport stroller or a ramp for the car. It took over 2 years for me to convince our agency that we should use some of our tightly held medicaid funds to purchase a ramp for this family's van, so that they could more easily transport their child to medical appointments or simply to go sit in a quiet park and enjoy the day. This same kind of story is repeated endlessly. Even though I have worked for my agency for 5 years, I continue to have to beg for the simplest piece of medical equipment. An adaptive tricycle, which will help a child with Cerebral palsy build their core strength: many many forms, begging and waiting. Diapers, shower chairs so parents do not get back strain or risk hurting their child in the bath, transportation to one of the very few and very overcrowded after school programs. Medicaid cuts will not only endanger their regular healthcare from the few doctors who accept MediCaid, but will make their lives not very much worth living. **Dear Senators:** 

I am one of the many millions who stand to lose health care coverage if Medicaid is taken away. In 2009, in the worst of the depths of the Great Recession, I was laid off from my job working for local government. Following the loss of my job I fell into a deep depression. Thanks to Medicaid I receive a prescription antidepressant-that costs more than \$200/month for free, a cost-I could never afford to pay out of pocket. Without the medication I could never have been able to return to school and work toward becoming once again a productive, taxpaying member of society, which is all I want to be. I recently graduated with my Master's Degree in Statistics, which I could not have achieved without Medicaid for the simple reason that I could not have afforded the costs of school tuition and fees, health care and the costs of daily living simultaneously.

If the ACA were repealed, insurance companies will once again be able to deny people coverage or charge unaffordable rates for people with pre-existing conditions. Because I now have a pre-existing condition I will be one of the people denied coverage or charged unaffordable rates. So am I irresponsible? Should I have been more responsible for keeping my job when the economy collapsed? Should I have been more responsible by choosing to pay for health insurance instead of the Master's Degree that will lead me to a higher-paying job in a more stable career field which will in turn lead me to be the responsible, taxpaying citizen you want me to be?

If people with pre-existing conditions who can't get health insurance are irresponsible, is Jimmy Kimmel's baby irresponsible? This baby was born with a life-threatening heart condition and will have a pre-existing condition for the rest of his life. Would you tell this baby that he should have made a more responsible choice than to be born with a pre-existing condition? How can it be pro-life to deny this baby the medical treatment he needs when his life has barely begun?

In the wealthiest nation on earth, the fact that we are *still* unwilling to treat health care as a right available to all regardless of color, income or creed is a disgrace. That child lives, like that of Jimmy Kimmel's baby, are considered political fodder rather than a sacred responsibility by every adult is unjust and shameful and in no way pro-life.

You, the ever powerful United States Senate, will soon have a choice to make when Senate Majority Leader Mitch McConnell brings the deeply harmful, flawed, unpopular and misnamed Better Care Reconciliation Act (BCRA) — it should be called the Worse Care Reconciliation Act — to the Senate floor for a vote. This draconian bill will unravel decades of progress fighting for more health equity and justice for all. I hope every voter will stand up for children, the disabled, the elderly, the mentally ill and the most vulnerable among us and make sure those who vote against them are held accountable.

At a time when 95 percent of children in America have health coverage after years of laboriously achieved incremental progress with bipartisan leadership and the percentage of uninsured Americans is at a record low, will you vote for renewed pain and suffering or forward progress? Will you vote to

end Medicaid as we know it — a lifeline for more than 37 million children and more than 40 percent of children with special health care needs — to pay for a giant tax cut for wealthy Americans and corporations who don't need or deserve it? Will you vote to rip away health coverage from 22 million Americans and leave millions more paying a lot more for skimpier coverage? Will you vote to undermine coverage for essential services for children and other Americans including those with pre-existing conditions? Will you vote to strip important and popular protections, returning us to a day when discrimination based on age, gender, health status and ability to pay is permitted? Will you vote to deprive millions of Americans mental health and substance abuse treatment in the midst of a national opioid crisis?

You may be wooed with "fixes" being negotiated behind the scenes that tinker around the edges of the cruel, unjust Better Care Reconciliation Act, but make no mistake: it is irreparably flawed and no altering of growth rates and caps, taxes, or creating special "funds" or "risk pools" will fix it. It deserves a swift and decisive death in the Senate if we are to keep any semblance of an American sense of fairness and moral decency alive.

Would you vote to deprive your own children, grandchildren, nieces and nephews of basic life supports? I suspect not. Denying children essential health care makes no moral or economic sense. Healthy children and adults make America stronger and safer. I witnessed the true benefits of Medicaid for my Mother who would not have been fully covered for her bypass surgery, her leg amputation, rehabilitation, nursing home facilities, medication and her treatment for cancer which ultimately took her life. She would not have had in home support services to have help with bathing and groceries or be able to afford a wheel chair, walker, shower bench and other necessary accommodations. All of this would have fell on her family who would have been devastated financially.

The Rretroactive Medicaid eligibility is a critical feature for millions of families---particularly those who are facing long nursing home stays, which cost \$10-12k PER MONTH. This eligibility can prevent families from going bankrupt from nursing home fees (and in most cases, there is no other option). Medicaid pays for 2/3 of nursing home payments in this country. We are facing an unprecedented number of aging seniors who will need nursing home care. I don't know many besides the wealthy who can afford to pay for this care.

I have worked for 9 years now as the Executive Director of the Down Syndrome Connection of the Bay Area where I see first hand every day what Medicaid means. I fully understand the devastation the cuts and caps will have. Access to early Intervention, many therapies, In home services, Independent living supports and much more. Medicaid allows people with disabilities to live a full productive life. To be part of society and contribute. It allows children to be included in school with typical peers because they get the supports they need to do so.

No one wants to be on Medicaid. 5.6 million people with disabilities depend on it! It is inhumane to take this away.

The so called "carve outs" says it will protect 1.2 million children is a blatant lie. Many carved out will NOT have access to Medicaid because they will be relying on "underfunded" state Medicaid programs who will not have the ability to serve everyone. That is just unacceptable.

The federal and state Medicaid program is the major and sometimes the *only* source of funding for long term supports and services that many people with intellectual and developmental disabilities rely on to live in the community. This effective and cost efficient program allows people with intellectual and developmental disabilities to live and work among their neighbors.

Most people with intellectual and developmental disabilities already don't have enough money to live on our own and we have to live with one or two roommates. Now there is an proposal to cut people's SSI when more than one person with SSI live together. We are already barely getting by.

Here is what needs to happen.

Congress should reject any cuts to Social Security or SSI, including any proposals to cut benefits or limit who can qualify.

Congress should request a beneficiary impact statement on any proposal to change Social Security or SSI, to look beyond budgetary issues to the impact on people's daily lives.

Congress should address the many areas in which improvements are needed in the SSI and Social Security disability programs.

Congress must understand that Medicaid is a necessity to people who have intellectual and developmental disabilities and their families!

Congress should protect the individual entitlement to Medicaid.

Congress should reject reductions or caps to the Medicaid program, and reject any effort to block grant Medicaid.

Congress should address the nation's need for an affordable, accessible system of health care and long term supports and services.

Congress should not repeal the Affordable Care Act without simultaneously replacing it with a law that maintains or improves the coverage, including the long term services and supports change, in the ACA.

Members of Congress should act to remove the institutional bias of federal programs, eliminate waiting lists for long term supports and services, and to strengthen the right to community living for individuals with disabilities.
