For more then a decade I have come to now many people with a DD/MI diagnoses and substance use affliction. I have witnessed firsthand how people's lives have been changed by engaging in programs such as supported employment, skill building, community living supports, ACT, drop in centers, wellness, long/short term substance abuse rehab and so on. These programs help people attain skills, build confidence, and help them become a more active participant in their own lives. Any cuts to Medicaid threatens the quality of life and independence of people with disabilities. It will limit care for those afflicted with substance use, when there is so little care already available. It will directly effect families seeking respite to help maintain their health and relationship to those they care for daily and beyond typical years when children leave the home.

I am also a family member of DD, MI, and substance use affliction. Without Medicaid the father of my children would not be able to get the help he needs. I honestly believe he would not be with us right now if it was not for the assistance a Medicaid funding. Medicaid funding allowed him to go to detox, attend 1:1 therapy, and provides assistance with proper medications depression. My daughters would be without insurance. This would directly affect the therapy my daughter is getting due to her struggle with anxiety and depression.

All recipients of Medicaid have access to Lifeline and without it, I would be in big trouble.

I also have pre-existing conditions which would be used against me and prohibit me from getting the medical care I need at a rate I could afford.

As a recipient of Medicaid I also qualify for help paying for my prescriptions. I would not be able to afford them without being on Medicaid which then allows me to be on the "Extra" program which pays my monthly prescription plan premium and co-pays.

In closing, this very predatory bill should be blocked and I sincerely hope the Senate finally realizes no one wants to get rid of Medicaid or Obamacare.

In January Medicaid approved his Vegas Nurve Implant to reduce seizures. It's June and the VNS has stoped hundreds of seizures. He has worked at Walmart for the past 2 years. Due to his seizures he had to reduce hours to 8 hrs a week and be very tired when he got home. Now he is working 32 hours a week and doing great.

My grandson is now 6 and has been diagnosed with autism.

Medicaid has helped him with getting the medical needs and services he needs.

Without Medicaid both of these very special individuals would have very poor quality of life or not be here anymore .

Our family has 3 members who receive Medicaid services in order to live in their own home. If Medicaid cuts go through my family will probably lose these benefits and have to live in an institution or die.

My husband is disabled and relies on in-home help for every aspect of daily living including incontinence. I also use an electric wheelchair for mobility and cannot care for his daily needs myself. He is paralyzed and can only get around in a motorized wheelchair. Medicaid Waiver pays for his help so that he can remain in our home. If we didn't have home help he would end up in a nursing home where he would die in a short time due to all his medical needs.

We have two adopted adult children who are disabled and are currently living in their own apartment with help paid for by Medicaid. If they did not have this help they would be put in an institution or group home with their independence taken away. Our son, Robert, has autism and epilepsy and our daughter, Sherri, has schizencephaly (similar to cerebral palsy) and many other medical issues.

In addition to home help, Medicaid helps pay for our doctors, medications, durable medical equipment, etc.

I would like to express my concerns regarding the Better Care Reconciliation Act and how it will affect individuals with developmental disabilities. Medicaid is the only insurance that a person with a developmental disability before age 18 is able to obtain unless they are also covered by a parents coverage until age 26. Medicaid coverage currently is very limiting and with few doctors available to provide quality health care.

My son needs ongoing physical therapy, PM&R, neurological, PCP, dental and vision coverage due to his disability. Finding doctor's that are taking new patients or are wanting to assist someone with multiple medical issues is difficult. More limitations to the medicaid plans would be devastating to his overall health care and quality of life.

It appears when individuals in governmental positions what to change health care; their target population to cut are the individuals most vulnerable and in the need of the most assistance. I would imagine that if there were imposed limitations and caps set upon governmental officials to match the rest of the US citizens, the discussion on health care would look much different.

I have Uncontrolled Epilepsy, Memory issues, Muscle Jerks, Hypothyroidism, IBS, Urticaria, Dermatographism, Eczema, Insomnia, Obstructive Sleep apnea, Migraines, Fibromyalgia, Diverticulosis, Depression with Anxiety, Myofascial Pain, Neck Pain, Midline low back pain, RUQ pain, Chronic low back pain, Knee pain, Arthralgia of Right hip, Osteoarthritis, Pruritus, Heart murmur, Dry Eyes, Macular Degeneration, Hypertension, TMJ, Vagus Nerve stimulation for Epilepsy(this does not help), Venous insufficiency of both lower extremities. I am currently going through testing to see if I could receive Brain Surgery (Neuropace). I cannot have other Brain Surgeries; both sides of my Brain is involved. I have tried all Medications without help. I am currently on 3 different seizure medications. Doctors do not want any patient on more than 2 medications at the same time.
